Now that the survey is complete, the Commission on Paraoptometric Certification (CPC) and its committees are working diligently alongside Professional Testing Corporation (PTC) to develop the blueprint for the new examinations that will be released in 2025.

We need paraoptometrics and doctors who are interested in learning how to write new test questions using the updated outlines. Additionally, paraoptometrics who can serve as item reviewers to analyze each new proposed item will be needed. These are both great opportunities to learn a new skill and earn continuing education credit.




Congratulations!

Reminder to future CPOTs

The Commission on Paraoptometric Certification (CPC) will start offering a single written CPOT examination beginning in 2025. Paraoptometrics who are seeking the CPOT certification in 2024 and those who have already passed either portion of the CPOT examination must pass both portions of the CPOT examination by the end of the November 2024 testing period.
